MATERIAL FEE	\$200.00	Pre School
TUITION FEE	Infant Care 5 Full Days (0 – 24 months)	\$ 2300.00 per month
	3 days (Available only for 12–24-month-old)	\$ 1650.00 per month
	2 days (Available only for 12–24-month-old)	\$ 1250.00 per month
	Pre School (5 / 4 full days 7:00 am – 5:30pm)	\$ 1450.00 per month
	5 Days (7:00am – 4pm)	\$ 1300.00 per month
	3 full days (7:00 am – 5:30pm)	\$ 1050.00 per month
	2 full Days	\$ 850.00 per month
	Daily Fee – Pre School	\$ 80.00 per Day
	For Preschool there will be a \$60.00 Diaper Change fee a month. This charge will remain until the child is fully potty trained.	
RETURN CHECKS	\$20.00 will be charged on the return checks. If a cheque is returned after the 20 th of the month the late fee too must be paid. (For Pre school)	
LATE CHARGE	\$20.00 must be included on payments made after the 10 th of the month.	
TO ENROLL	The registration fee, first month tuition, and the material fee must be paid by the first day of school. <i>Withdrawal from school requires one month written notice or one month tuition. Tuition credit cannot be given for miscellaneous absences from the school, vacations taken during the school year and for early withdrawal in the month of June.</i>	
SCHOOL HOURS	The school opens at 7:00 a.m. and closes sharp at 5:30 p.m. <i>PARENTS MUST GIVE THEMSELVES SUFFICIENT TIME TO PICK UP CHILDREN AND THEIR BELONGINGS IN ORDER FOR OUR STAFF TO CLOSE AT FIVE THIRTY.</i>	
LATE PICK UP	Pick up after 5:30 p.m. is charged at <u>\$60.00 per hour (\$1.00 per minute)/per child.</u>	
Optional Lunch Program	\$ 6.50 per meal. Please refer to the school office to sign up for same.	

Any payments in arrears of forty-five days may be sent for collection. All legal and other charges incurred in collecting overdue accounts will be charged to the parents.
